Taxes & duties that may be levied by the Govt. will be extra as applicable and shall be borne and deposited by the highest successful bidder before lifting of material. GST as applicable will have to be deposited by the highest bidder over and above the bid amount before lifting the material(stores).
- 3. The purchaser/bidder may inspect the material from On any working day between 15.10.2021 to 10.11.2021 from 12.00 Noon to 3.00 PM by prior appointment Principal tele 01995-261066 to satisfy themselves about the quality & condition of the materials offered. No complaint whatsoever will be entertained after the tenders are submitted or before or after
